

ROYAL BANK YOUNG AMBASSADOR 2023 REGISTRATION/APPLICATION Terms and Conditions

1. Royal Bank Young Ambassador Programme 2023 is open to Scottish Rugby Union member clubs and their members, and agents of the NatWest Group companies and their family members. Scottish Rugby employees including Rugby Development Officers and Community Officers employed by the Scottish Rugby Union are not eligible for this programme. All rugby clubs that register for Royal Bank's Young Ambassador Programme in 2023 must be affiliated with the Scottish Rugby Union.
2. All applicants for the Royal Bank Young Ambassador programme must be aged 18-35 as of 24th March 2023 and members of official rugby clubs affiliated to Scottish Rugby.
3. Applications for the Royal Bank 2023 Young Ambassador Programme open from 24th March until 11:59pm on 28th May 2023. Individuals must be registered to be eligible to receive any incentives.
4. There can be more than one Young Ambassador application per club, although it is unlikely that there will be more than one applicant selected from the same rugby club. Applications are not returnable or updateable. Applications must be submitted via the online submission form found on the Royal Bank Rugby website at <https://www.rbs.co.uk/clubgrants>. They, and the copyright in them, become the property of the Promoter and Scottish Rugby.
5. Decisions regarding the 15 recipients with a place in the class of 2023 Young Ambassadors will be made by 15th June 2023 and applicants will be notified by email and/or phone within seven working days.
6. Applications not submitted in accordance with these rules, delayed, damaged, incomplete, altered, or illegible will not be accepted. No responsibility is accepted for delayed registrations. Proof of sending by email or post will not be accepted as proof of registration. Proof of upload to website will not be accepted as proof of entry.
7. All registered clubs agree to take part in publicity in connection with Royal Bank Young Ambassador Programme and also agree to invest any Regeneration funds and/or resources allocated to their rugby club by the Royal Bank of Scotland plc for the purposes of the Royal Bank Young Ambassador Program 2023, into their club.

8. All applicants and participants in the programme agree that their personal data may be processed by the Promoter and Scottish Rugby for the purposes of this promotion.
9. By taking part a representative from each club agrees to complete a post-event survey to feedback on the Royal Bank Young Ambassador Programme.

They, and the copyright in them, become the property of the Promoter and Scottish Rugby.
3. Applications not submitted in accordance with these rules, delayed, damaged, incomplete, altered, or illegible will not be accepted. No responsibility is accepted for delayed applications. Proof of sending by email or post will not be accepted as proof of application.

4. The following incentives are on offer for all registered Young Ambassadors:
 - a. Access to bespoke application feedback and Young Ambassador communications
 - b. Digital support toolkits
5. The following incentives are on offer for the select 15x Young Ambassadors:
 - a. £500 Regeneration grant to improve/kick start your clubs climate action
 - b. Royal Bank Young Ambassador merchandise

 - d. Support and development from Scottish Rugby's regional development team
