

## Royal Bank of Scotland Team GB Prize Draw Terms and Conditions

- a. Our Team GB Prize Draw is open to customers aged 18 or over who hold an eligible current account and an eligible instant access savings account with Royal Bank of Scotland, and who are UK residents.
- b. The prize draw is not open to employees of The NatWest Group of companies, their families or anyone associated with this draw.
- c. Entry into the prize draw is automatic for any customer who:
  - a. does not have Round Ups turned on and then turns Round Ups on in the mobile app between 17<sup>th</sup> June at 12.00pm and 12<sup>th</sup> August 2024 at 5.00pm,  
or
  - b. is an existing Round Ups user with the email marketing preferences enabled, who receives an email from Royal Bank of Scotland inviting them to enter the prize draw, and who follows the link between receipt of email and 12<sup>th</sup> August 2024 at 5.00pm,  
or

Customers who want to turn on Round Ups between the 17<sup>th</sup> June and 12<sup>th</sup> August 2024 but don't want to be entered into the prize draw have the option to opt out by emailing [savings@rbs.co.uk](mailto:savings@rbs.co.uk) with their full name, current account sort code and account number.
- e. Eligible current and savings accounts must be open and operational at the time the winners are selected.
  - a. All our current accounts are eligible for Round Ups except for Select Lower Rate and Revolve.
  - b. All our savings accounts are eligible for Round Ups except Fixed Term Savings Products and ISA's.
